IT Nation® PitchIT™ Contest Official Rules

THE CONTEST IS VOID WHERE PROHIBITED BY LAW. BY PARTICIPATING, YOU AGREE TO THESE OFFICIAL RULES.

- 1. Contest Overview: The IT Nation 2023 PitchIT™ Contest ("Contest") is designed to recognize startups that have built their technology stack on the ConnectWise platforms or integrated their technology stack with the ConnectWise platform or participate in the ConnectWise Invent program and meet the eligibility requirements. Sponsor will select three (3) finalists ("Finalists") from among all eligible entries to compete and present their pitch at PitchIT™ 2023. The three
 - a. (3) finalists ("Finalists") will compete for the Grand Prize at the IT Nation™ PitchIT™ Contest. The Finalists will present their business pitch live to a panel of judges and the IT Nation Community at IT Nation Connect during the 2023 PitchIT™ Contest. Sponsor reserves the right to reduce the overall prize payouts at each selected level or terminate the Contest without awarding a prize if it does not receive a sufficient number of qualified and eligible entries. If the Contest is terminated, Sponsor will post a notice on www.connectwise.com/theitnation.
- 2. Entry Period: The Contest entry period begins on February 1, 2023 at 8:00:00 a.m.ET and ends on April 30, 2023 at 11:59:59 p.m.ET ("Entry Period"). Entries submitted after the Entry Period may be accepted by ConnectWise in their sole and absolute discretion. Sponsor's computer will be theofficial clock of the Contest. All times in these Official Rules are eastern time.
- 3. Sponsor: The Contest is sponsored by ConnectWise, LLC ("Sponsor" or "ConnectWise"). In these Official Rules, the terms "we," "us," or "our" refer to ConnectWise, LLC, and the terms "you" and "Entity" refer to you, the entrant, both as an individual and as part of the Entity.
- 4. Administrator: The Contest is administered by ConnectWise, LLC, 400 N Tampa Street, Suite 130, Tampa, FL 33602.
- 5. Eligibility: If you have participated in PitchIT previously, your re-entry is subject to ConnectWise's approval. The Contest is open only to Entities who: (a) are independent and separate legal entities (C corporation or LLC); (b) are in compliance with all applicable laws, acts, regulations, rules, and ordinances in the state in which they are incorporated; (c) have not received more than \$10,000,000 USD in aggregate cash funding sinceformation of the Entity; d) have at least \$25,000 USD gross revenue on an annual run rate basis (calculated using the Entity's gross revenue in its most recent quarter, multiplied by four (4)) at its sole discretion ConnectWise may choose to waive the domicile and revenue requirement; (e) have built the Entity's technology stack on the ConnectWise platforms or integrated their technology stack with the ConnectWise platforms; (f) are not under bankruptcy protection or have judicial liens or attachments; (g) do not promote, sell, or advertise any products, ideas, or services that fail to comply with all applicable laws, acts, regulations, rules and ordinances; and(h) are not under current investigation, or are not currently a party to or have been convicted ina civil or criminal matter. The person entering on behalf of the Entity must be a person with authority to bind the Entity to these Official Rules. Sponsor reserves the right to disqualify an entrant that Sponsor determines could potentially reflect negatively on Sponsor's image. VOID WHERE PROHIBITED BY LAW. An Entity is not eligible to participate if any one of the company's officers, C-suite executives, directors, employees, consultants or contractors at any point since July 1, 2017: (a) is or was employed by (or worked as a consultant for) ConnectWise, their respective affiliates or any of their direct or indirect wholly or majority owned subsidiaries; (b) is

- a. the immediate family (spouse, parents, siblings, and children) or household member of any of the employees, consultants or contractors in (a) above; (c) provided service as an officer, C-suiteexecutive, director, employee, consultant or contractor of an entity in which Sponsor, , or their subsidiaries or affiliates have invested or holds an ownership interest; or (d) the Entity or any of its officers, C-suite executives or directors were selected as a finalist or a winner of any sweepstakes or contest sponsored or organized by ConnectWise, and affiliates or any of their direct or indirect wholly or majority owned subsidiaries that offered a prize to any winner with acash value of \$15,000 USD or more.
- 6. Entry: You must submit your Entity's entry during the Entry Period. An Entity may only submit one (1) entry. Incomplete entries may be disqualified. Your entry must consist of the following:
 - a. A complete entry form application A signed commitment to participate in the PitchIT Accelerator Program as designed by ConnectWise. All materials related to the entry must be in English. By submitting an Entry, you represent and warrant that: (i) You have read and agree to these Official Rules; (ii) You have fully complied with these Official Rules; and (iii) the Entity's technology stack is built on or integrated with the ConnectWise platform. We reserve the right to disqualify any entry that is offensive, as determined by us, in our sole discretion. Please ensure your entry is appropriate for all viewing audiences. We reserve the right to assess your eligibility and compliance with these Official Rules at any point during the Contest. If we require any assistance in order to assess your compliance, you must promptly provide that assistance. If youdo not provide the requested assistance in a timely manner, or if we have reason to believe thatyou are not complying with the Official Rules, you may be disqualified, in our sole discretion.
- 7. Judging Criteria and Process: Round 1: Following completion of the PitchIT Accelerator Program, all entrants will be required to complete a virtual pitch and Sponsor or its designee will review all entrants and select three (3) eligible entrants with the highest scores to move on to the application and eligibility review process ("Review Process"), according to the following Judging Criteria ("Judging Criteria"), each of which will be scored on a scale between 1 to 5 points: (a) the ability of the current team to execute; (b) innovation in the existing marketplace; (c) understanding of market size and ability to capture market share; (d) company culture and team dynamic; and (e) use of the ConnectWise platforms. The eligible entrants will be notified on or about September 5, 2023 that they have been selected for the Review Process. Entrants agree to speak with ConnectWise representatives during the Review Process to determine eligibility and compliance with the Official Rules. For purposes of clarity, participating in the Review Process does not make you a Finalist. You are not a Finalist until you receive an official email confirmation from ConnectWise that you have made it and willbe attending IT Nation PitchIT™as a Finalist. The Finalists will be notified of their confirmation on or about September 4, 2023. The executive of each Finalist who will be presenting the Entity's live business pitch as part of Round 2 agrees to participate in one (1) practice and mentorship session prior to IT Nation PitchIT™ for the purpose of polishing their business pitch. Round 2: One or two executives representing each Finalist and who have the authority to bind the Entity agree to present their live business pitch at IT Nation PitchIT™ in front of a panel of judges. Each Finalist will be required to give a 5-minute presentation and answer questions raised by the judges. The Finalists will be competing for an investment opportunity of up to \$70,000 USD from

- a. ConnectWise, LLC. The executive(s) of each Finalist who will be presenting the Entity's live business pitch at IT Nation PitchIT™ agree to (i) participate in the 16-week PitchIT Accelerator Program beginning in May 2023 prior to IT Nation PitchIT™ for purposes of improving their business pitch and materials, (ii) provide Sponsor with their final business pitch presentations and technical requirements no later than one week prior to the finals event, (iii) participate in a dry-run prior to IT Nation PitchIT™ 2023 and (iv) participate in press interviews set up by ConnectWise. Failure to adhere to any of the aforementioned activities or provide the required materials may result in a disqualification and forfeiture of any prize. If we become aware of a potential conflict of interest on the part of a judge due to his or her relationship to a contestant or otherwise, we will determine an appropriate course of action in our sole judgment. Entries may be subject to a due diligence review by Sponsor or ConnectWise at any time for eligibility and compliance with these Official Rules. Contestants must provide any such additional information as may be required in order to remain eligible. Determination of eligibility and compliance is at our sole discretion and may result in the disqualification of an entrant.
- b. ConnectWise's decisions and those of the judges are final and binding. In the event of a tie, in any round, the judges will re-evaluate the tied entries according to the Judging Criteria until thetie is broken.

If a live event is held, all Finalists are responsible for their own airfare travel, hotel accommodations, meals, lodging, ground transportation and any other travel and expenses. Grand Prize: During Round 2, the judges will use the Judging Criteria to select in their sole and absolute discretion one (1)Grand Prize winner.
- 9. Two prizes will be awarded: 1st place will receive a \$70,000 prize and 2nd place will receive a \$30,000 prize; (ii) authorization to use the Designations (as defined below) during the Term set forth below; and (iii) a ConnectWise Launch Package consisting of:
 - a. All PitchIT participants who have completed the 16-week PitchIT accelerator program are eligible for a PitchIT Sponsorship package as outlined below:
 - i. Exclusive sponsorship pricing for one (1) IT Nation Connect 2023 Kiosk sponsorship (\$15K)
 - ii. Exclusive sponsorship pricing for one (1) IT Nation Secure 2024 Kiosk sponsorship (\$12K)

 - iv. Pitch IT finalists are eligible for up to a 20% off discount for a Silver sponsorship at IT Nation Secure 2025 and IT Nation Connect 2024 or a free Diamond Sponsorship at one regional U ser Group 2024 of your choice. All sponsorships are subject to ConnectWise standard terms and conditions.
 - v. The prize distribution will be subject to the terms between ConnectWise and the winner as specifically set forth in the funding agreement between you and ConnectWise. Such terms of agreement may include but are not limited to, a confidentiality agreement, participation in ConnectWise's then terms and conditions required by ConnectWise.
